

### **XIII GÉRARD BOULVERT INTERNATIONAL PRIZE IN ROMAN LAW**

*The «Gérard Boulvert Society for the Study of European Civilization and for the History of its Legal Systems», in agreement with the Journal Index and accepting the invitation issued by Italian and foreign institutions and scholars, announces the Thirteenth Gérard Boulvert International Prize in Roman Law. This award aims to encourage the development of research in Roman Law and to recognize, in the name of Gérard Boulvert, the works of young scholars of all nationalities published in the preceding three years.*

1. The competition is hereby announced for the *Thirteenth Gérard Boulvert International Prize in Roman Law* for a “first work” in the form of a monograph devoted to any of the sub-disciplines of Roman Law and to the other legal traditions of classical antiquity.

2. The amount of the prize, which cannot be reduced or shared, is twelve thousand euros (12,000 euros). The winner will also be awarded the medal of the University of Naples Federico II.

Special prizes, bestowed by the Jury, will be made available by the Constitutional Court of the Republic of Italy, by the Institut de Droit Romain, University of Paris-Panthéon-Assas, by the Centro Romanistico Internazionale Copanello (the *Henryk Kupiszewski Prize*), by the University of Fribourg, by the Joseph Winkel Foundation (“Hans Ankum Prize” and “Rolf Knütel Prize”), and by other universities and organizations.

3. The competition is open to scholars who have published, even electronically, or presented in its final form in a manner consistent with the rules and practices of various countries, their first monograph on topics concerning the disciplines specified in article 1 above during the triennium 2022 – 2023 – 2024.

4. Entries – using the form which can be downloaded from the website [www.premioboulvert.unina.it](http://www.premioboulvert.unina.it) – must reach the President of the Boulvert Prize Jury, Professor Martin Schermaier, at [boulvert@unina.it](mailto:boulvert@unina.it), by December 31<sup>st</sup>, 2025.

On or before the same deadline five copies of the work entered in the competition must be sent to the Secretariat of the Prize, Prof. Valeria Di Nisio c/o Consorzio Boulvert, via Porta di Massa 32 - I - 80133 Napoli, as well as a PDF, c/o [boulvert@unina.it](mailto:boulvert@unina.it).

Works written in languages other than Italian, French, German, English, Spanish or Latin must be accompanied by a detailed summary (at least 20 pages) in one of these languages.

5. The Board, in its final, reasoned judgment, will award the Prize in the year 2025.
